**Submissions are OPEN – Deadline on Tuesday, May 5, 2026.** *Pride Art Show* is presented by PFLAG of Clinton Township, hosted by the Anton Art Center with support from Macomb County Pride, and juried by Phil Gilchrist.

### Eligibility

LGBTQ2S+ artists, United States residents ages 18 and older, are invited to submit up to two original entries completed within the last four years to be juried. Open to all media; limit 40 inches in any direction. All works previously displayed at the Anton Art Center are ineligible. Additional guidelines for submissions are available on our website ([theartcenter.org/exhibit-philosophy](http://theartcenter.org/exhibit-philosophy)).

### Entry Procedure

- **Take** clear photos of artwork (may include framing, if applicable). One photo per 2-D work or three photos per 3-D work. JPEG image files should not exceed 2MB. **Label** image files as: Artwork Title\_First & Last Name\_Media\_Dimensions.
- **Email** image(s) to [exhibitions@theartcenter.org](mailto:exhibitions@theartcenter.org) (or via digital entry form at [theartcenter.org/artist-opportunities](http://theartcenter.org/artist-opportunities)) by submission deadline to be eligible for jurying.
- **Complete** and Submit entry form (page 2) by email, mail, or deliver in person or digital entry form by deadline.
- **Submit** entry fee payment of \$15 per artist for up to two artwork entries by deadline via PayPal to [information@theartcenter.org](mailto:information@theartcenter.org), check payable to 'Anton Art Center', charge (Visa, Mastercard, Discover, or American Express) online ([theartcenter.org/submit-a-payment](http://theartcenter.org/submit-a-payment)), by phone, or in office, or cash in person.

*Note: A \$25 service charge is applied to any returned checks. Entry fee is non-refundable.*

**SUBMISSION DEADLINE:** All entry materials (entry form, entry fee, and artwork image(s)) must be received by **Tuesday, May 5, 2026, 4:00PM EST.** *Submissions are accepted through the deadline listed.*

### Artwork Delivery

Accepted artworks and artist materials (Artist Statement and/or CV) may be delivered to the Anton Art Center by the receiving date listed. Artists are responsible for transportation and/or shipping arrangements and costs both to and from the Anton Art Center. Artwork must be unwrapped and ready to be safely and securely installed upon arrival. Due to limited storage space, we are unable to store any packaging materials, except for shipped work. Please provide installation instructions, if applicable. The Anton Art Center reserves the right to remove work that does not comply with standard installation and safety guidelines.

### Awards

**First Prize \$150 • Second Prize \$100 • Third Prize \$75 • Honorable Mention Award (3) \$25 each**

Awards to be decided by our guest juror.

### Sales

The price submitted with entry form is the final retail price. Artists must provide insurance value for artwork if work is designated 'not for sale' (NFS). The Anton Art Center retains 40% of the retail price on all works sold; please price artwork accordingly.
