ELIGIBILITY: Artists aged 18+ are invited to submit original sculpture in any medium.

JUROR AND AWARDS: Works will be juried by Ray Katz. Cash awards totaling \$425 will be given for 1st, 2nd, 3rd places, and honorable mention, as well as gift certificate awards (for Runyan's Pottery Supply) totaling \$225.

GUIDELINES

- Artists may submit up to 4 sculpture entries of any medium.
- An entry fee of \$25 for Sculptors' Guild of Michigan members in good standing (2026 dues paid in full) and \$35 for nonmembers is required.
- Entry Form & Non-Refundable Entry Fee **must be submitted by 11:59 pm on June 1, 2026.**

Size Limits

Limit 48 in. x 48 in. x 72 in. (L x H x D) and 300 lb. for floor work; 24 in. x 24 in. x 24 in. and 30 lb. for pedestal or ceiling-hanging work; 48 in. x 48 in. x 4 in. and 30 lb. for wall-hanging work

Artwork Labeling Requirement

Each artwork must be clearly labeled securely on the back or bottom with the artist's name, title of work, medium, dimensions, and price (or NFS-not for sale).

Artwork Entry Information & Digital Submission Requirements

- Submit up to 3 images per artwork (include front and back views).
- Label each file with your last name and artwork title (e.g. smith_still waters_front.jpg).

- *Sculptors' Guild of Michigan* reserves the right to reject any entry that differs from the-submitted images, or is unsuitable in size, or is deemed unsuitable for space considerations.
- Email all images in JPEG format. Images should be good resolution but not to exceed 500KB per image. Convert iPhone pictures to jpeg using <https://imazing.com/>

- Artwork must be ready for display upon delivery. If your pieces require special installation (e.g. floor or wall mount, lighting, etc.) please include with your art details in the special instruction box of the chart below, with the art piece information.

Commission & Sales

- *Anton Art Center* takes a commission of 40% that will be deducted from the sale price of the artwork sold, if sold. If not for sale, please list NFS (Not For Sale) in the price area of paperwork.
- During the exhibition period, all sales transactions will be made through the *Anton Art Center* (a staff member with the *Anton Art Center* will process all sales).

Delivery, Shipping & Liability

- Artists are responsible for all costs and arrangements related to the delivery and return of their artwork.
- The *Sculptors' Guild of Michigan* will not be responsible for shipping art.
- Artists are responsible for any assembly and set-up of their work.
- All entries will be handled with all possible care. The *Sculptors' Guild of Michigan* and *Anton Art Center* assume no responsibility for loss, theft, or damage while at the gallery.
