



## CALL FOR ENTRY

### Michigan Annual LI

Juror Meighen Jackson  
January 27 – February 24, 2024



The 51<sup>st</sup> annual statewide fine art competition is juried by Meighen Jackson and hosted by Macomb County's long-standing premier arts & cultural nonprofit organization, the Anton Art Center.

### Eligibility

Michigan artists ages 18 and older are invited to submit up to two original entries completed within the last two years. Open to all media; no size restrictions. All works previously displayed at the Anton Art Center are ineligible. ### Entry Procedure

- **Take** hi-res photos of artwork (include any framing). One photo per 2-D work or three photos per 3-D work. JPEG image files must not exceed 1.5MB. **Label** files as follows: Artwork Title\_First & Last Name\_Media\_Dimensions (inches: *height* x *width*). **Email** images to [exhibitions@theartcenter.org](mailto:exhibitions@theartcenter.org) by submission deadline listed.
- **Complete** entry form provided on page 2. **Send** form by email, mail, or deliver in person by submission deadline listed.
- Entry fee is \$30.00 per artist for up to two artwork entries. **Submit** entry fee payment by deadline via PayPal to [information@theartcenter.org](mailto:information@theartcenter.org), check payable to 'Anton Art Center', charge (Visa, Mastercard, Discover, or American Express) by phone or in office, or cash in person. *A \$25 service charge is applied to any returned checks. Entry fee is non-refundable.*

**DEADLINE:** All materials are due by the deadline: **Tuesday, January 2, 2024, 4:00PM EST**

We are now accepting submissions. *The Anton Art Center Administration Office will be closed for the holidays December 24th through January 1st. The building will re-open on Tuesday, January 2nd at 10:00AM.*

### Artwork Delivery

Accepted artworks and artist materials (Artist Statement and/or CV) may be delivered to the Anton Art Center by the receiving date listed. Artists are responsible for transportation and/or shipping arrangements and costs both to and from the Anton Art Center. Artwork must be unwrapped and ready to be safely and securely installed upon arrival. With the exception of shipped artwork only, we are unable to store any packaging materials. Please provide installation instructions, if applicable. The Anton Art Center reserves the right to remove work that does not comply with standard installation and safety guidelines.

### Awards

**First Prize \$1,000 • Second Prize \$600 • Third Prize \$400 • Honorable Mention Award (3)**

Awards to be decided by our guest juror.

### Sales

The price submitted is the final retail price. Artist must provide insurance value for artwork not for sale (NFS). The Anton Art Center retains 40% of the retail price on all works sold; please price artwork accordingly.
