ELIGIBILITY

Open to new and existing members of the Lakeside Palette Club of St. Clair Shores, Mount Clemens Art Association, Romeo Guild of Art, Shelby Township Fine Art Society, and Warren Tri-County Fine Arts Association, Inc. Visit www.theartcenter.org/exhibit-philosophy for group contact information for new or renew artist membership. Artworks must be original, gallery ready, and completed within the last two years. All works previously displayed at the Anton Art Center are ineligible. Juried by Lori Zurvalec. Shared theme of 'the outdoors' in any style, medium, and interpretation.

PRESENTATION

- All media are acceptable, including painting, drawing, sculpture, glass, metal, fiber, photography, etc.
- Maximum of 40 inches in any direction, including any framing, and 30 pound maximum weight.
- All entries must arrive ready to be safely and securely installed. Pedestals are available for 3-D work.
- 2-D work must be prepared to hang by appropriate weight-bearing wire or French cleat.
- Any mat board must be neutral in color (white, black, etc.). Plexiglass recommended for 18x24 in.+.
- Any other methods of display must be reviewed and approved prior to entry.

NOTE: The Anton Art Center reserves the right to remove artwork prior to jurying that does not comply with standard presentation guidelines and rules listed. Please contact us with any questions.

ENTRY PROCEDURE

- \$15 entry fee per artist
- Artists may submit up to two artworks
- Fill out entry form and label(s) and secure to back- or under-side of artwork(s)
- Submit completed entry form, entry fee, and labeled artwork(s) to the Anton Art Center on designated receiving day and time only to be eligible for jurying

AWARDS

1st Prize \$150 • 2nd Prize \$100 • 3rd Prize \$75 • Three Honorable Mentions Prizes at \$25 each Awards are chosen by our guest juror. Award ribbons and checks are provided by the Anton Art Center.

SALES
